



OUR MISSION

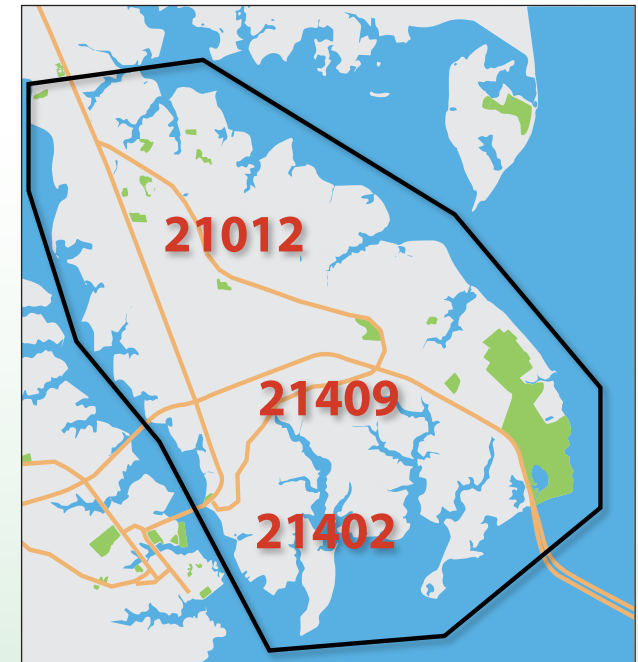
Protect the Broadneck Peninsula from environmental degradation, overdevelopment and inadequate transportation corridors.

BCC ACTION PLANS



- Represent BCC members on Broadneck issues at state and local government meetings
- Support controlled Smart Growth to ensure an environmentally sustainable future
- Require improved stormwater management facilities at development sites and regular inspections by qualified County engineers
- Provide leadership for the AA County General Development Plan (GDP) and the Broadneck Small Area Plan (SAP) that have significant impact on land use decisions on our Peninsula
- Improve roadway access and public safety for residents and commuters impeded by traffic congestion on U.S. Route 50/301 & MD Route 2
- Reduce upzoning, special exceptions, variances and modifications resulting in overdevelopment
- Support AA County Police, Fire and EMS providers....who work to secure our public safety
